

Privacy Collection Notice – Lottery

1. Who We Are

The Council of the Queensland Institute of Medical Research, trading as QIMR Berghofer ("we," "us," or "our")

2. QIMR Art Union

QIMR Berghofer is conducting the art union (the "lottery") and has engaged Karingal St Laurence Limited (trading as 'genU') to assist with administering the lottery, including ticket processing and related services.

QIMR Berghofer is committed to protecting your privacy in accordance with the *Information Privacy Act 2009* (Qld). To the extent that QIMR Berghofer collects your Personal Information in connection with the lottery, this Privacy Collection Notice will apply. Our Privacy Policy contains further information about how we collect, use, store and disclose your Personal Information. 3. Why We Collect Your Information

QIMR Berghofer collects Personal Information for the following purposes:

- to raise funds for medical research;
- marketing to supporters and donors about research;
- conducting appeals and events;
- requesting and processing donations, gifts and bequests;
- retaining accurate financial records;
- maintaining relationships with supporters and donors;
- recording communication preferences;
- building profiles on supporters and donors; and
- organising fundraising events and lotteries.

QIMR Berghofer will use your Personal Information for the lottery to:

- Administer and conduct the lottery, including notifying winners and distributing prizes;
- Process and manage ticket sales;
- Comply with legal and regulatory obligations; or
- For any other purpose related to the operation of the lottery, as permitted by law.

4. Types of Personal Information We Collect

The kinds of information collected includes names, date of birth, contact details, bank account/credit card details, as well as information about an individual's interests in QIMR Berghofer's functions and research, attendance at events, donations, gifts or bequests (including payment details) and any other information required to retain accurate records and build and maintain relationships with supporters.

5. How We Collect Information

As far as possible, QIMR Berghofer will collect Personal Information from individuals directly. However, Personal Information is also collected from corporate partners, agents acting on

behalf of QIMR Berghofer and supporters, open source publications and prospect research consultants.

6. Legal Basis for Processing

We collect and use your information only where:

- You have given consent;
- It is necessary to fulfil a contract or legal obligation; or
- It is in the public interest or for legitimate business purposes.

7. Disclosure of Information to third parties

Your Personal Information may be hosted by or disclosed to third parties such as:

- Karingal St Laurence Limited trading as 'genU'; and
- Government authorities (if required by law).

Such hosting or disclosure will only occur where:

- We are satisfied on reasonable grounds that the recipient or service provider is subject to privacy obligations that are substantially similar to those under Queensland law; or
- Another permitted situation under the *Information Privacy Act 2009* (Qld) applies.

We will take reasonable steps to ensure your Personal Information is handled in accordance with the Queensland Privacy Principles (QPPs), including by contract or other binding arrangement.

8. Data Breach Notification

In the event of a data breach likely to cause harm, we will notify you and the Queensland Office of the Information Commissioner (OIC) as required by law.

9. Access and Correction

You have the right to:

- Request access to your Personal Information;
- Correct inaccurate or incomplete details.
- Contact our Privacy Officer at PrivacyOfficer@qimrb.edu.au to exercise these rights.

10. Complaints

If you believe we've breached privacy laws, contact our Privacy Officer. You may also lodge a complaint with the Queensland OIC:

11. Consequences of Not Providing Information

If you choose not to provide required information, we may be unable to process lottery ticket purchases from you or provide you with updates on the winning ticket.

12. Retention Period

We retain your information only for as long as necessary to fulfil the purposes outlined in this notice or as required by law.
